Delinquency interest accrues at 1% per month on all delinquent taxes and special district fees. Any partial payments tendered will be applied to oldest debts first and in compliance with city ordinance outstanding liens will be paid before other debts owed. Residential properties meeting the criteria for phase-in of the taxable assessment increase have been identified here by the "Act 718" notation and the tax computations adjusted accordingly. Those properties eligible for phase-in for 2020 and 2021 may be affected by the 5% assessment decrease for 2022 due to Hurricane Ida.

ATTENTION TAXPAYERS
